

**IN THE MUNICIPAL COURT OF THE CITY OF OLATHE, KANSAS
FINE SCHEDULE FOR ORDINANCE TRAFFIC INFRACTIONS
EFFECTIVE 07/01/2010**

IT IS BY THE COURT ORDERED that persons charged with committing ordinance traffic infractions, in violation of the Olathe Municipal Code sections listed below, shall have the right to enter a written appearance by mail or by person, waive the right to trial, enter a plea of guilty or no contest and pay the specified fine by mailing a check or money order to the Olathe Municipal Court, 1200 S. Harrison, Olathe, KS 66061.
